Biographical Sketch

Berte Haigh

Born in Los Angeles, California, on June 15, 1890, Haigh obtained his grade school education at Buena Park, California, and from 1905 to 1921 worked with auto mechanics or military activity. He served in the California National Guard and in the U. S. Army during World War I. From 1921 to 1925, he attended the Texas College of Mines and Metallurgy at El Paso, majoring in metallurgy and minoring in geology. He graduated with a degree in Mining Engineering. Haigh worked as an engineer with Virginia Mines and then as a geologist for Dixie Oil Company. He then worked for his alma mater as assistant professor of geology and engineering until 1934. At that point, Haigh joined the staff of Texas University Lands, serving as geologist, supervising geologist, and then geologist in charge. Even after his retirement, he continued to serve as consulting geologist for the Lands System. While Haigh worked for Texas University Lands, he developed or assisted in developing many oil and gas leasing techniques later adopted by many public agencies in this country and in foreign nations.
