These fees are assessed in addition to any duplication costs and are separate from any fees that may be assessed by the copyright owners if the Petroleum Museum does not own the copyright or if the material is not in the public domain.
- 4. Manipulation of the images is subject to restrictions. Resizing, rotating and/or minor color corrections are allowed. However, for any manipulation affecting the image composition, the requester must have prior approval from the Petroleum Museum.
